Questions to ask prospective Divorce Clients

Client Name, phone and email to contact you **today**.

What county do you and your spouse live in? Is it Dallas? If no, where?

Have you or your spouse lived there more than six months?

Do you earn more than \$1,500 per month?

Does your spouse know you are filing for divorce?

Will your spouse sign the paperwork or will they contest the divorce?

Have you discussed the terms and condition of the decree with your spouse, **including the amount of any child support?**

Is anybody seeking alimony? How much per month and for how long?

Do you or your spouse own real estate to be included in the order

Has a divorce been filed? If so, case number, court number and which county, If no, move down to #19

Have you been served? When?

Are there any court dates set in the future?

Is there a lawyer on the other side and , if so, who and what is the name, address phone and email

Do you have children under the age of 18 and not yet graduated from high school?If no, go to #25

How many?

Are any of the children under 18 married, pregnant, in the armed services or live on their own?

Are the children the subject of a prior court order, such as child support or Attorney General (Date of judgment, court and case number)
